 - Will be admissible to the Government employees who have not been allowed any special or additional allowances;
 - Will be part of pay and allowances for the purpose of income tax; b)
 - Will be admissible during leave and entire period of LPR, excluding Extra c) Ordinary Leave;
 - Will not be treated as part of emoluments for the purpose of calculation d) of pension and gratuity;
 - Will be applicable w.c.f July 01, 2021, and shall continue until reduced or discontinued; and
 - Will be made part of pay and allowances on repatriation of a civil employee f) to the Government of Balochistan.

NOTIFICATION.

No.FD(R-I)V-1/2021/1731-1850/. The Government of Balochistan has been pleased to grant Adhoc Relief Allowance-2021 @ 10% on the running basic pay of Basic Pay Scale-2017 to the civil employees and 10% increase on monthly pension to the civil pensioners w.e.f 1st July, 2021. The said allowance/increase in pension shall be admissible to civil employees & Pensioners in BPS-1 to BPS-22 of Government of Balochistan subject to the following conditions: -

Adhoc Relief Allowance-2021 @ 10%.

- i. The Adhoc Relief Allowance-2021 shall be provided with the following terms and conditions, that the allowance:
 - a) Will be admissible to all the regular employees of the Government of Balochistan from BPS-01 to BPS-22;
 - b) Will be part of pay and allowances for the purpose of income tax;
 - c) Will be admissible during leave and entire period of LPR except during Extra Ordinary Leave;
 - d) Will not be treated as part of emoluments for the purpose of calculation of pension and gratuity;
 - e) Will be applicable w.e.f July 01, 2021, and shall continue until enhanced, reduced, or discontinued and
 - f) Will not be admissible to contract or contingent paid staff, who may be governed as per the terms and conditions agreed at the time of original contract or upon renewal of the contract.

Basic pay means the basic pay including personal pay currently drawn and duly enhanced through annual increment according to the applicable Pay Scale.

The above Adhoc Relief Allowance-2021 shall in first instance be met out of the budgetary allocation through re-appropriations timely made. In extremely rare circumstances where provision of supplementary grant is inevitable and all the possible re-appropriation options have been exhausted only then a supplementary budget may be proposed.

Increase in monthly pension to the Civil Pensioners and their families @ 10%

The increase in the monthly pension to Civil Pensioners and families shall be subject to the following conditions: -

- a) Will be paid to the civil pensioners on the net pension derived at the time of retirement devoid of the applicable increases allowed from time to time and the medical allowance including increase in medical allowance admissible to the pensioner;
- b) Will be allowed to all civil pensioners including their families, that is, to the admissible family pension drawn; and
- C) Will be applicable w.e.f July 01, 2021 and shall continue until enhanced, reduced, or discontinued by the Government, as the case may be.
