COMPENSATION PACKAGE FOR COVID-19 SHUHADA AND IN SERVICE GOVERNMENT EMPLOYEES WHO DIED DUE TO COVID-19

The undersigned is directed to refer to your letter No.SO(Dev:)H/30-28/2020-21/5994-98, dated 23rd September, 2021 on the subject cited above and with prior approval of the Hon'able Chief Minister Balochistan vide summary No.PS/Prin:Secy/(CM)/3904, dated 22nd December, 2020 the Finance Department conveys its concurrence as under: -

- i) Shaheed Package as one-time lump sum grant of Rs.1,000,000/- (Rupees one million only) to the families of deceased who expired due to COVID-19.
- ii) This package shall be in addition to other benefits admissible to the family of deceased civil servants' under relevant rules/Policy.
- iii) Package mentioned above shall be allowed on recommendation of the Committee constituted to process the cases for declaration of COVID-19 victims as "Shaheed".
